The Thomas Jefferson Planning District Commission (TJPDC), with support from the City of Charlottesville, and the counties of Albemarle, Fluvanna, Greene, Louisa, and Nelson, was awarded a grant through the U.S. Department of Transportation's Safe Streets and Roads for All (SS4A) Discretionary Grant Program. This funding will be used to develop a multi-jurisdictional Comprehensive Safety Action Plan, known as Move Safely Blue Ridge.

The purpose of the SS4A program is to help communities significantly reduce roadway-related fatalities and serious injuries.

Move Safely Blue Ridge will be under development through spring 2025, and there will be many opportunities to get involved. Over the next few months, the Move Safely Blue Ridge team will be hosting meetings and events to get feedback on transportation safety issues in our region.

In-person Meetings

From June 10th to 12th, the Thomas Jefferson Planning District Commission (TJPDC) hosted community meetings for Move Safely Blue Ridge across Albemarle, Greene, Fluvanna, Louisa, and Nelson counties, as well as the City of Charlottesville. Attendees at these meetings had the opportunity to share detailed feedback about their safety concerns in the region.
