Regional Economic Strategy Update & Economic

Each year the Regional Commission reviews and updates the Regional Economic Strategy (RES). The purpose of and local partnerships to address economic development in

the RES is to continue federal and local partnerships to address economic development in the region. The RES also documents the planning efforts to identify economic development needs in the region and the creation of the strategy document.

At the June 27th NRVRC board meeting, the final 2024 Regional Economic Strategy document was approved. This year's document features updates to our updated top projects, and sections on resilience and recovery. The final document can be found at https://nrvrc.org/economy/

The Regional Commission continues to enhance the accessibility and engagement of the RES and key information through an interactive <u>digital format</u> and a <u>data dashboard</u>, maintained by the Regional Commission, providing user-friendly demographic, economic, and community health data for local governments, grant writers, non-profits, and citizens.



Opioid Abatement Best Practices Workshop

The New River Valley Recovery Ecosystem (NRVRE) was highlighted at a Virginia's Opioid Abatement Authority (OAA) hosted workshop in Hampton, VA in June. The statewide workshops target local governments and funding agencies that are eligible for direct and competitive OAA awards. Holly Lesko provided an overview of the NRVRE focusing on the partnerships and integration of services and programming this regional approach allows. Chris Alderman, Harm Reduction Coordinator with New River Health District (NRHD), also presented about the Rise Above program funded through the NRVRE cooperative program. This is a wonderful example of impactful partnership with a service agency and local government entities. The local government and state funder response to the NRVRE model was positive which is a strong indicator of impact and sustainable funding.

NRV Recovery Ecosystem Year Two

The Virginia Opioid Abatement Authority Grants Committee met last month to review funding recommendations for FY25, noting a record number of proposal submissions this year. The NRV Recovery Ecosystem is pleased to announce the approval of the Year 2 Renewal package with a slight increase in funding totaling \$3,526,202. This decision ensures the continuity of current programs and introduces new collaborative opportunities, including partnerships with three new agencies.

Newly funded initiatives include the development of a pilot program for public schools, expanded peer support services across the region, and enhanced on-demand transportation options. Regrettably, funding requests for housing vouchers, supportive housing, and treatment facility expansion were not approved for this cycle. However, the project leadership team remains steadfast in their commitment to these crucial elements of the recovery ecosystem and will actively pursue funding opportunities for them in the future.




NRVRC Staff Service Activity
