Safety Performance Measures and Targets



Proposed CY2020 targets to be adopted by CTB at June meeting

Annual Safety Performance Measures	2020 Target
Number of Fatalities*	950
Rate of Fatalities per 100 million VMT*	1.08
Number of Serious Injuries*	7,473
Rate of Serious Injuries per 100 million VMT	8.47
Number of Non-Motorized Fatalities and Serious Injuries	711

^{*}Safety Performance Targets common to both VDOT and DMV

 New methodology to be shared in detail with MPOs to aid their 2020 target-setting efforts

Highway Safety Improvement Program (HSIP) Policy



- Data-driven target-setting effort revealed greater ROI from systemic and hybrid safety improvements
- Developing policy to prioritize HSIP funding to systemic and hybrid projects
- Draft presented to CTB in May
 - Received lots of feedback on policy and process

Reliability: Target Setting and Refining the Measure



- **Develop a Data-Driven Target Setting Methodology**
 - Peer review for alternative methodologies
 - Analyze factors to establish baseline conditions and predict future conditions – develop a model of key variables
 - Evaluate anticipated benefits of projects and strategies
 - Incorporate anticipated project benefits into baseline model to establish data-driven targets
- 2. Evaluate current investment strategies, i.e. Safety Service Patrol, and the sources for unreliability and contribution of each source to understand what is/isn't working
- 3. Evaluate other measures that may be more useful in evaluating investment strategies and decision-making

Reliability: Target Setting and Refining the Measure



- Data-driven target setting methodology has revealed limited utility of federal reliability measure as an indicator of performance at less than statewide or network level
- **Developing alternative measure that is more** applicable to regional or corridor-level analysis and is more sensitive to infrastructure and operational improvements

Congestion and Reliability: Considerations for Selecting Measures



- What is the goal of the measure?
- How many and which aspects of congestion are included?
- What is the geographic scope of the measure and is it scalable?
- Is it sensitive to the types of projects, strategies, or policies we want to evaluate?
- Who is the audience?
- Is data available to create the measure?

Asset Management Pavements and Bridges



- Internal workgroup evaluating current investment strategies
- Legislative requirements to report back on vital structures
- Anticipate presentation of additional or alternative performance measures for the entire network for pavements and bridges

Performance Data



- We plan to make MPO-level performance data for CY2018 available to MPOs by September.
- OIPI will develop a short performance report for the federal measures and targets to show current performance levels.
- Biennial Report due to the Governor and General Assembly by Nov. 1.
 - This report includes reporting on performance of the surface transportation network.
